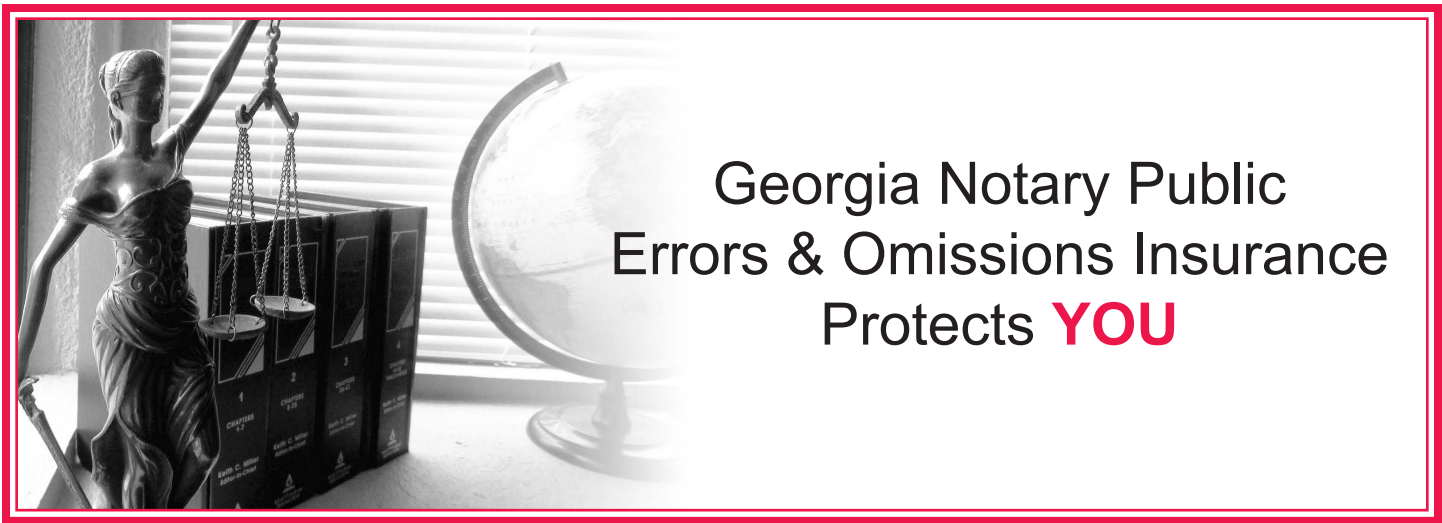
Application Process - Instructions will be emailed to you on how to complete the application process with the Clerk of Superior Court.
